Students attending the "Glebe Collegiate Institute Ski Trip" will be staying at Chalets Mont Sainte-Anne, situated at the base of Mont Sainte-Anne.

The condominiums are fully equipped with a complete kitchen, dishwashers, microwaves and fireplaces. Each four-bedroom unit accommodates 8 persons, and each five-bedroom unit accommodates 10 persons.

All students can receive a 90 minute skill improvement session (group lesson) the first day of the trip. Students must pre-register for these lessons.

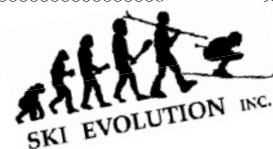
