Students attending the "Loyola Grad Ski Trip" will be staying at *Condos Vacances MSA*, situated 2km from the base of *Mont Sainte-Anne*.

The condominiums are fully equipped with a complete kitchen, dishwasher, microwave and fireplace. Each two-bedroom unit accommodates 5 persons. The complex also offers an outdoor heated pool, outdoor hot-tubs, and a well established arcade room.

Beginner & novice skiers & riders will receive a compulsory skill improvement session the first day of the trip. All students must wear helmets while skiing and riding.

Students are expected to bring food from home. Some meals can be purchased in the ski hill cafeteria.

Your ski passes are valid for Friday (12h30-21h00) and Saturday (08h30-21h00).

Rental Equipment: Students are responsible for their rental equipment. Lost or stolen rental equipment will cost the student \$600 (snowboard) or \$550 (skis). Students are not to leave their equipment unattended at any time. All students must wear a helmet (they can be rented for \$18 if you do not own one).
