- ✘ This form is for skiers and snowboarders (riders) who want to use terrain parks containing "Extra Large" (TG-XL) features;
- ✘ Access to these terrain parks will be controlled and restricted to advanced and expert riders who have a valid access card;

## Logical Style: an attitude to adopt.

### Look before you leap!

- ✘ You are responsible for inspecting Freestyle Terrain before initial use and throughout the day;
- ✘ The features vary in size and change constantly due to snow conditions, weather, usage, grooming and time of day;
- ✘ Do not jump blindly. Know your landing is clear;

### Easy style it!

- ✘ Always ride or ski in control and within your ability level;
- ✘ You control the degree of difficulty you will encounter in using Freestyle;
- ✘ Warm up, start small and work your way up.

### Respect gets respect!

- ✘ Respect Freestyle Terrain and others;
- ✘ Respect all signs and do not enter Freestyle Terrain or use features when closed;
- ✘ Wait your turn, call your start and clear the landing area quickly.

## Risk Recognition

The following are specific risks applicable to terrain park(s) with TG – XL features :

I know the terrain park(s) includes various manmade or natural features such as, rails, ramps, banks, fun boxes, jibs, walls, hits and various size and surface features used to carry out freestyle manoeuvres.		
I acknowledge that performing freestyle manoeuvres requires a high skill level to maintain control both on the ground and in the air.		
I know the feature size designations : Small (P-S) Medium (M) Large (G-L) Extra Large (TG-XL)		
I know that features marked TG-XL are of a larger size, which can be taller, stronger angles and kinks, more pronounced shapes, and combinations or sequences of features which require a lot more skill.		
I acknowledge that the use of features marked "Extra Large" (TG-XL) can represent increased risk, that the height of the features are bigger than in regular parks.		
I acknowledge that risks associated with the use of terrain parks and in particular TG-XL features are, but not limited to, the following : <ul style="list-style-type: none"> <li>✘ Injury from falls or other movements (dislocation, sprains, fractures etc.)</li> <li>✘ Injury from objects in the park, either blunt or sharp (features, rails, box, snowboard, ski, ski pole, etc.)</li> <li>✘ Injury resulting from accidental or non-accidental contact between users.</li> </ul>		
I know that inverted aerial manoeuvres are prohibited, since they can increase the risk of permanent serious injury and even death.		
I agree to a daily inspection run of the park and features and progressively try the different features according to my skill level.		
I acknowledge that conditions can change or worsen during the day and that I will remain attentive and adjust accordingly..		
I am the only - and best - judge of my freestyle riding ability and my capability to use terrain parks, particularly those with TG-XL features.		
I understand that wearing a helmet is mandatory and I am aware that, although it helps to reduce the risk of serious head injury, it cannot entirely eliminate the risk of such injury. I also understand wearing a helmet does not prevent injury to the face, neck or spine.		
I acknowledge that the ski area has the right to decide which helmets are accepted.		
I am aware that this sport can damage my equipment and clothing.		
Non-observance of terrain park regulations and/or the Alpine Responsibility Code can lead to the suspension or withdrawal of the terrain park access card and/or lift ticket or season pass.		
I understand that the access card is personal and is not transferable and I commit to show it each time I enter a restricted access terrain park or upon request.		

### Risk Recognition

- I am aware of the terrain parks rules/regulations and commit to respect them;
- I acknowledge I was informed of the inherent risks involved in using terrain parks and, in particular, TG-XL size features;
- For purposes of this document, I agree: (1) to reside in Quebec, which will be the location of any possible claims and (2) that the laws of Quebec will apply;
- I am able to use the terrain parks with TG-XL size features with **full knowledge and I accept the risks** related to this activity.
